ORDER

This Bench shall also attend the matters of amalgamation above 50 lakhs paid up capital whenever assigned by Hon'ble President through Special Order.
3. After taking up matters listed before the Division Benches, Hon'ble Members (Judicial) of the Division Benches shall sit Single separately and take up matters listed before Hon'ble Member for such Single Bench.
4. This Order shall come into force with effect from 22nd May, 2017.
